TERMS OF BUSINESS

6. Definitions

- 6.1. PT Longitude 106 East henceforth referred to as Long106.
- 6.2. All definitions as given on the booking Form (which shall be deemed in every respect to form part of these Conditions) shall apply in these Conditions. In addition, the term client shall include, where appropriate, all or any of the members of the crew, and any other person from time to time on board the Yacht at the Client's invitation, for whose acts or omissions Client shall also be liable.

7. General

- 7.1. The Yachts are insured against accidents and third party liability, but responsibility is not accepted for personal accidents, damage or loss due to your negligence. You are advised to arrange your own insurance in this regard.

8. Payment

- 8.1. The deposit is non-refundable once a booking has been accepted.
- 8.2. In the event of a booking being cancelled prior to two calendar months prior to commencement, Long106 may refund up to 50% of deposits paid but reserves the right to retain the total amount paid.
- 8.3. In the event of a course being cancelled by Long106 due to circumstances beyond their control, Long106's liability will be limited to the return of the fees and deposits already paid.
- 8.4. Unnecessary damage and losses attributed to carelessness of a client will be paid for by that client at the replacement price. Fair wear and tear will be taken into consideration.
- 8.5. Client shall pay to Long106 the Deposit upon returning the Booking Form to Long106 at which time these Conditions shall become binding.
- 8.6. Prior to the Commencement of the Course, the Client shall pay to the Long106 the balance of the Fee due. If the Client shall fail to do so, Long106 may treat the booking as cancelled and act on the basis of that cancellation.
- 8.7. Long106 may cancel the booking at any time upon the repayment to the client of all sums already paid.
- 8.8. Should a client fail to attend after making full payment, Long106 shall be entitled to keep the sum paid.

9. Client obligations

- 9.1. Client hereby agrees as follow:-
 - 9.1.1. That the details provided by him in the booking form are complete and accurate;
 - 9.1.2. To comply with all requests of Long106 on-board staff with reference to the operation and safety of the vessel;
 - 9.1.3. That the Client will accept sole responsibility for the behaviour and adherence of instructions of any person's under the age of 18 years and absolve Long106 from any responsibility should such a person suffer loss or injury.
